**Approve Agenda-** Motion made by Tony Smith and seconded by Mark Peterson to approve the agenda. Motion passed unanimously.

**Approve November 27, 2023, Meeting Minutes**- Motion made by Mark Peterson and seconded by Tony Smith to approve the November 27, 2023, meeting minutes. Motion passed unanimously.

**Region Finance Information- November and December 2023 Financial Reports-** Motion made by Kathy Hanafan and seconded by Bernard Pettinger to approve the November and December 2023 financial reports. Motion passed unanimously.

Approve Amended Ending FY23 Fund Balance and Certification Letter - Watson presented a document indicating the amended fund balance FY23 in the amount of \$1,594,605 and the reason for the amended amount. Motion made by Mark Peterson and seconded by Scott Halverson to approve the board chair to sign off on the certification form. Motion passed unanimously.

## Approve contract update with Zion Integrated Behavioral Health for Harbor Point CSRS-

Watson presented a document indicating the reason for the update to the contract and change to the number of guaranteed bed days paid by region. Motion made by Bernard Pettinger and seconded by Kathy Hanafan to approve the updated contract. Motion passed unanimously.

Approve request to fund DEC Conference featuring Dr. Chasnoff- Maguire presented information about the Drug Endangered Children conference including details about the budget and cost of presenters. The conference will be about substance abuse prevention and working

with the adolescent population affected by substance use. Region Leadership requested \$5000 to help sponsor the one-day conference. Motion made by Tony Smith and seconded by Curtis Hamstra to approve the requested amount. Motion passed unanimously.

Approve funding amount for CHI/Children's Square Children's Center of Excellence for Behavioral Health- Watson shared that a small group made up of CHI staff, Children's Square staff, Region, and BWBR Architectural firm, have been meeting to discuss and potentially plan for a children's center for excellence in behavioral health at the Children's Square campus in Council Bluffs. Examples of services at the center include inpatient hospitalization, partial hospitalization, crisis stabilization residential services, and an assessment center. Watson presented a document with a summary of the project and breakdown of projected costs. Watson requested a financial investment in the amount of \$600,000 to be paid this fiscal year towards the programming, schematic design and design development by the architectural firm which will set the project in motion and build momentum for fund raising for the project. Motion made by Kathy Hanafan and seconded by Tony Smith to approve the funding amount for the proposed children's center for excellence in behavioral health at the Children's Square campus. Motion passed unanimously, with Halverson abstaining.

Legislation Updates and update on Behavioral Health Districts (ASOs)- Watson had recently emailed a document of an outline by Iowa Health and Human Services regarding a bill planned to be put forth by the Governor's office soon which will affect the MHDS Region structure. The Board had a lengthy discussion of the impact of these changes on the MHDS Regions and other local government agencies. Watson will forward to the Governing Board any further information and legislation as it is released.

**Update on CCBHC (Certified Community Behavioral Health Clinics)-** Mary O'Neill from Heartland Family Services gave a brief overview of CCBHC programming including how it is currently funded and brief overview of the CCBHC Planning Grant that the State of Iowa is applying for though the Federal Government. Mary discussed how this CCBHC Federal Grant could impact funding in the future.

**Region Services and Other Provider Updates**- Maguire presented data in a new graph presentation produced by Molly Brown which includes data for the Region's central intake, service coordination, crisis service coordination and resources and referrals calls. Maguire also provided updated information regarding the upcoming X factor training for law enforcement funded by the Region. No other updates given.
