Approve Agenda- Motion made by Bernard Pettinger and seconded by Mark Peterson to approve the agenda. Motion passed unanimously.

Approve January 29, 2024, Meeting Minutes- Motion made by Mark Peterson and seconded by Kathy Hanafan to approve the January 29, 2024, meeting minutes. Motion passed unanimously.

Region Finance Information- Approve January and February 2024 Financial Reports- Motion made by Scott Halverson and seconded by Mary O'Neill to approve the January and February 2024 financial reports. Motion passed unanimously.

Advisory Board Input and Recommendations from March 22, 2024, Meeting- Lonnie Maguire shared that the Advisory Board met on March 22nd. The group reviewed the current HHS Realignment legislation and members offered feedback. In addition, the board reviewed and approved the FY25 Annual Service and Budget Plan unanimously.

Approve FY25 Annual Service and Budget Plan- Suzanne Watson reviewed the plan with the board, allowing for questions. Motion made by Tim Wickman and seconded by Scott Halverson to approve the FY25 Annual Service and Budget Plan. Motion passed unanimously.

Update on CHI/Children's Square Children's Center for Excellence- Watson informed the board there have been further developments regarding the sustainability of this project from CHI. In sum, the program would not meet expenses after further research was done on its operating costs. With this information, Watson did not move forward with issuing the previously approved check that was to go to CHI for development and planning of the Center for

Excellence. CHI is still looking at putting parts of the original service array in existing structures on their main campus in Council Bluffs.

Overview of Governor's HHS Realignment Legislation- Watson shared an overview of the HHS draft legislation per the latest amendment. With the redesign, there would be seven Behavioral Health Districts throughout the state. Within the districts, Administrative Service Organizations (ASOs) would be responsible for receiving and managing state funds, contracting, and quality assurance/data. In addition, there would be Aging and Disability Resource Centers whose focus will be working with long term care populations, including Aging, Brain Injury, Chronic Mental Illness, and Intellectual Disabilities. Districts will be responsible for crisis services and writing a plan to comply with substance use, mental health, and tobacco directives. A large focus of the realigned system is prevention, education, and recovery. Timelines for the changes include that district maps would be available August 1, 2024, ASOs would be designated by December 31, 2024, and ASOs begin their work on July 1, 2025.

Other Legislation Updates- Danelle Bruce shared that much of the focus this session is on the realignment bill as well as the AEA bill. There is a "Work Without Worry" bill that would revamp the state's MEPD system to increase income and resource limits for disabled individuals who choose to work. There is also a bill that would direct HHS to submit for a federal waiver to allow jail inmates to retain their Medicaid benefits while incarcerated.

Region Services and Other Provider Updates- Maguire presented data in graph presentation for the Region's central intake, service coordination, crisis service coordination and resources and referrals calls through February 2024. Danelle Bruce shared that Crisis Intervention Training (CIT) will take place in Council Bluffs April 15-19, and we are still seeking additional law enforcement personnel to register. No other updates given.

Open Discussion/Comment from Board Members- None

Public Comment/Discussion- Darren Shull of Integrated Telehealth Partners (ITP) shared a graphic of jail telehealth services used in the region for the period from December 2023-February 2024.
