**Approve Agenda-** Motion made by Kathy Hanafan and seconded by Bernard Pettinger to approve the agenda. Motion passed unanimously.

**Approve June 3, 2024, Meeting Minutes-** Motion made by Mary O'Neill and seconded by Kathy Hanafan to approve the June 3, 2024, meeting minutes. Motion passed unanimously.

Region Finance Information- Approve June, July, and August, September 2024 Financial Reports- Watson shared a summary sheet in addition to monthly financials with the board. She indicated the region will be tracking payments monthly from providers to ensure payments are being submitted and processed timely as the budget is very tight. Kim Maassen from the region will also be assisting with some additional aspects of claims processing to ensure timeliness of payments. Motion made by Steve Kenkel and seconded by Curtis Hamstra to approve the June, July, August, and September 2024 financial reports. Motion passed unanimously.

Approve September 1, 2024, Heartland Family Service Contract- Watson reviewed the contract with the board and highlighted changes within for Community Support Services, Individual Peer Support Services, and Rural ACT payments. Motion made by Kathy Hanafan and seconded by Scott Halverson to approve the September 1, 2024 Heartland Family Service contract. Motion passed unanimously with Mary O'Neill abstaining.

**Review new Monthly Financial Reports Submissions to HHS**- Watson shared that HHS is now requiring a region monthly financial report to be submitted by the 5<sup>th</sup> of each month. An example September 2024 report generated from CSN was shared with the board. Several region budgets are much tighter this year than in years past, including SWIA MHDS, due to the 5% fund balance requirement. Watson noted the accruals amounts appear to be off on the

report, so staff will investigate this and report back to the board at our next meeting. Regions must also track and report the balance of leave payouts (vacation and comp time plus any benefits for possible retirees).

Approve Decision to Stop Reimbursement of Mental Health Medications to Region Jails-Danelle Bruce shared with the board that payment of mental health medications in our region jails has been something we could do when we had more funds available, but this is not a required service/item that we must pay for. In looking at our tight budget for this year, this line item is one area in which we could cut, and the leadership team is recommending we stop payments as of October 1. Bothwell shared that costs for medications can be quite high monthly, especially for small jails. Several indicated they did not like having to cut this but understood the need due to our tight budget. Motion made by Steve Kenkel and seconded by Mary O'Neill to stop reimbursement of mental health medications to region jails as of October 1, 2024. Motion passed unanimously.

**Advisory Board Update**- Lonnie Maguire reported that the Region Advisory Board met on September 20<sup>th</sup> and had a good meeting. In addition to discussing the RFP for the ASO's, the group was able to perform a SWOT analysis. Leadership got a lot of good feedback that will be useful in the RFP process. The group discussed that the makeup of the advisory board/council will be different under the behavioral health ASO's. At this time, we will pause our next meeting as further developments occur with the ASO's.

**Update on Planning for the Behavioral District ASO**- Watson shared the current district map presented by HHS and explained that leadership recommends the region applies for both District 1 and District 4 to increase our chances of a successful bid. The region is applying as Pottawattamie County doing business as Western Iowa Services Collaborative (WISC) for Behavioral Health. Staff have been working on the RFP and have been collaborating with staff from Rolling Hills Region, who serve several of the counties in District 1. The RFP is due October 18<sup>th</sup>. The RFP for the Disability Access Points has not come out yet.

**Region Services and Other Provider Updates**- Lonnie Maguire presented data in graph presentation for the Region's central intake, service coordination, crisis service coordination and children's crisis services for July and August of 2024. Danelle Bruce shared the region held a 24-hour Advanced De-escalation training for corrections in September, and 15 individuals attended. In addition, X-Factor training for law enforcement will take place November 4<sup>th</sup> and 5<sup>th</sup> in Council Bluffs and invited board members to share this information with law enforcement in their counties.

**Open Discussion/Comment from Board Members-** Bernard Pettinger asked if there would be a governing board under the ASO structure. Watson shared there will just be an Advisory Council made up of 10 members, 3 of which will be elected public officials.
