Approve September 30, 2024, Meeting Minutes- Motion made by Tony Smith and seconded by Scott Halverson to approve the September 30, 2024, meeting minutes. Motion passed unanimously.

Region Finance Information- Approve October 2024 Financial Reports- Watson reviewed the October revenue and expenditure reports. Motion made by Mark Peterson and seconded by Mary O'Neill to approve the October 2024 financial reports. Motion passed unanimously.

Review October Monthly Financial Report Submission to HHS- Watson shared a printout of the October financial report that was submitted to HHS and reviewed the information therein.

Update on RFP for BH District ASO and Disability Access Point- Watson shared that regions were not asked to give verbal presentations last week by HHS regarding the BH District ASO RFP. A decision is supposed to be made on successful bidders by December 31st. Leadership have been working on the Disability Access Point RFP and are applying for both Districts 1 and 4 as Pottawattamie County DBA Western Iowa Services Collaborative (WISC). The RFP includes Information and Assistance, Options Counseling, Short-Term Services and supports, Long-Term Services and Supports, and HCBS waiver navigation. The RFP is due December 20th however the team aims to submit by the 13th.

Region Services and Other Provider Updates- Lonnie Maguire presented data in graph presentation for the Region's central intake, service coordination, crisis service coordination and children's crisis services. Danelle Bruce shared that Harbor Point has been down a few staff and Children's Square CSRS has seen a marked decrease in their census for November to date.

Open Discussion/Comment from Board Members- Mary O'Neill and Scott Halverson concurred they are having difficulty securing therapy staff. Steve Kenkel noted that today is his last meeting as his supervisor term will expire December 31st. The board thanked him for his years of service. Steve indicated his successor will be Mike Kolby.
